**ATTENTION:** Please submit this form in-person at the Groveport Recreation Center, along with proof of residency.

**GROVEPORT RESIDENTS:** If you live in the Village of Groveport, you will be required to bring a valid Ohio Driver License or State ID Card, accompanied by a Groveport Water Bill, another utility bill or tax bill.

**CORPORATE RESIDENTS:** If you work in the Village of Groveport and pay 2% income tax to the Village of Groveport, you are required to bring a valid Ohio Driver License or State ID Card and a recent pay stub showing the person's name and business address.

Once Village staff has established that you are a "resident", you will receive a Resident ID Card and will be eligible to receive "resident" program rates and daily fees for one-year at the Groveport Recreation Center & Groveport Aquatic Center, provided you present your Resident ID Card at our facilities. Resident ID Cards are FREE.
